#### How do I file a warranty claim for my ViewSonic® Privacy Filter Screen Protector?

This warranty is only valid for the first consumer purchaser. To file a claim for your replacement screen, please follow the instructions below. Thank you for choosing ViewSonic.

- 1. Fill out the Warranty Claim Form on 2nd page.
- 2. Include the following items in your package.
  - The completed Warranty Claim Form
  - The original screen protector you purchased in the original packaging
  - Proof of purchase = a legible copy of your sales receipt or invoice
  - A return address to send your replacement

- You'll receive a confirmation email to the email address you provide with a copy of your completed claim form once your package has been received.

All incomplete packages will be returned to sender as is. ViewSonic will not accept COD delivery. Shipper pays shipping costs for the return package. ViewSonic will cover the shipping cost when a replacement is shipped.

ViewSonic is not responsible for any loss or damages in transit by your shipper. We suggest checking with your shipper for available tracking methods if desired.

#### What is not covered by warranty?

User induced errors that are not covered under warrany are:
