Evaluation of the product involved a combination of automated, manual, and functional testing against the applicable success criteria within the Web Content Accessibility Guidelines (WCAG) 2.2 Conformance Level A and AA. The evaluation process included manual code inspection, screen reader testing, page-level interaction testing, and component-level testing. Tools and methods used included browser extensions such as Axe, WAVE, and Accessibility Insights, as well as the Accessibility Scanner. Component-level testing leveraged the axe-core library. VoiceOver was used to validate screen reader compatibility on macOS.
